NOTICE OF AVAILABILITY & PUBLIC MEETING

Environmental Assessment for Jinapsan Beach Road

The U.S. Department of Transportation, Federal Highway Administration (FHWA), in cooperation with the Government of Guam Department of Public Works (Guam DPW), as joint lead agencies, have prepared an environmental assessment (EA) to examine the potential environmental impacts of alternatives being considered for a proposed road to Jinapsan Beach located in the U.S. Territory of Guam. The Guam DPW is proposing to use funds from FHWA for this local roadway project. The proposed one-lane, 12-ft wide reinforced concrete road would provide two-way access from Government of Guam property adjacent to Tarague Beach Road on Andersen Air Force Base (AFB) to private property on Jinapsan Beach along the northeastern shore of Guam. The FHWA and Guam DPW will conduct a Public Meeting on:

The purpose of this public meeting is to provide information on the proposed project and review the findings of the EA. This meeting also provides the public with: (a) an opportunity to comment on the National Historic Preservation Act (NHPA) process underway for the proposal; and, (b) notice of adverse effect for one of the alternatives being considered in the EA.
